

of the amendment. Hon. J. S. Macdonald spoke against the Quebec resolutions as a proper basis for Confederation. On the Committee appointed to consider the constitutional difficulties of the country the Hon. Attorney General West no doubt remembered that they had voted together in favor of Legislature Union of such a Union he was still in favor. He could not therefore permit the resolution to pass with securing to sanction what he felt bound to condemn. The hon. member spoke at some length against Confederation and in favor of the amendment.

Mr. DUNKIN did not see that anything was to be gained by the mere substitution of one paragraph for another. He protested against the system of compelling members Session after Session to vote upon all sorts of propositions in amendment to the Address. The correct, and certainly the simplest plan was merely to vote nay on the paragraph. He had voted against amendments for the reasons he had said before, and he would do so now (Hear.)

Mr. DORION replied to Mr. Dunkin explaining that this object amendment was to pledge the House to submit the question to the people.

Mr. HOLTON briefly addressed the House and the yeas and nays were then called for on M. Dorion's amendment. While the members were being called in.

Mr. JOHN MACDONALD (Toronto), was permitted to address the House. His views had undergone a material change since he last addressed the House, though he was still opposed to the Quebec scheme. Then we had a Reciprocity Treaty, now we have none; then we were at peace, now we were almost at war. Besides, the English had expressed so much anxiety to see Confederation carried out, and as that was the only country he knew in the world which would put forth its whole strength to defend its humblest subject, he would not assume the responsibility of voting against the Address.

The vote was then taken, when the amendment was lost.

Mr. DUNKIN, in speaking to a motion for the adoption of a Report presented last Session, with reference to the business of the Private Bills Committee, explained, at some length, the inconveniences which beset the progress of private business in the House, and the means suggested to remove them. These were, to give one hour in two days of the week, and one whole sitting once a week exclusively to the despatch of private business. The motion was deferred until to-morrow.

Hon. Mr. HOLTON moved an Address for correspondences relating to the proposed Union of the British North American Provinces.—Carried.

Hon. Mr. HOLTON moved an Address for despatches on the defences of the Province. Some conversation took place on this motion between the Attorney General West and Mr. Holton, which did not reach the Gallery.

Attorney General MACDONALD moved a Special Committee of fourteen members, to prepare and report lists of members to compose Select Standing Committees.—Carried.

The Committee reported forthwith, naming the Select Standing Committees of last Session, substituting the name of Mr. McMonies for that of the late Mr. Notman.—The Report was carried.

Attorney General MACDONALD announced that to-morrow, after routine business, he would move that the House do adjourn, out of respect to the memory of the late members of the House (the late Mr. Notman, of North Wentworth, and the late Mr. McKenzie, of North Oxford.)

The House adjourned at half-past four o'clock.
