In light of the fact this country suffers from identical pressures to its economy, I move, seconded by the hon. member for Halton (Mr. Jelinek):

That this government take immediate steps to bring down a new budget to meet the same kind of urgent and pressing economic problems created by this government by reason of its profligate spending and total lack of control over the economy in general.

MOTION UNDER S.O. 43

**Mr. Otto Jelinek (Halton):** Madam Speaker, I rise under the provisions of Standing Order 43. Recently the British Labour Party urged the parliamentary labour party to vote against the constitutional resolution in the British House of Commons. Whereas four members of the federal NDP have stated that they will not support the constitutional resolution in this House of Commons, along with NDP Premier Blakeney's opposition to the package as a whole, and because, on the other hand, the secretary of the federal New Democratic Party, Mr. Robin Sears, has urged the British Labour Party to support the constitutional resolution, I move, seconded by the hon. member for Etobicoke Centre (Mr. Wilson):

That this House urges that, prior to the NDP stating their final position on the constitutional resolution, Mr. Broadbent, the Leader of the NDP, convene a meeting of Socialist International to include "the four horsemen" from his own caucus, the Premier of Saskatchewan as well as himself, so that the position of Socialist International can be clarified in order to avoid any misunderstandings to the British and Canadian public.

INCREASE IN PROFITS—MOTION UNDER S.O. 43
